Permission to Use “Certified Vegan” Logo

Vegan Action gives permission to **Sacred Foods, LLC** to use the “certified vegan” logo, hereinafter referred to as the logo, on the products listed below. The ingredients for these products have been certified by Vegan Action to be ‘vegan,’ as defined below.

The term ‘vegan’ is defined as containing no animal ingredients or animal by-products (to include honey and sugar refined with bone char), using no animal ingredient or by-product in the manufacturing process, and not being tested on animals by any company or independent contractor.

Sacred Foods agrees to use the logo only on those products specifically mentioned in this agreement that have been determined to be vegan. Further, should any of the ingredients in any product change, that product can no longer use the Certified Vegan Logo until an updated list of ingredients is received by Vegan Action and Vegan Action again certifies that product to be vegan.

If the Certified Vegan Logo is ever used by **Sacred Foods, LLC** in error on a product not certified by Vegan Action, **Sacred Foods, LLC** agrees to notify Vegan Action as soon as possible, cover up the logo on the uncertified products or destroy the incorrect labels. If any incorrectly labeled products have made it to the marketplace, **Sacred Foods, LLC** agrees to post a consumer notification on their website regarding their error. Misuse of the Certified Vegan Logo could result in a void contract and loss of Vegan Certification and the use of the Certified Vegan logo.

Sacred Foods, LLC agrees to pay the licensing fee on a yearly basis and understands that nonpayment may result in a void contract.
